Dried and denatured blood residues are removed by neodisher MediZym while being extremely kind to equipment.</p> <p>Stainless steel, instrument steel, light metals, glass, the usual plastics and the materials of anaesthesia equipment and flexible endoscopes are resistant to working solutions of neodisher MediZym.</p>
Application and dosage:	<p>For machine cleaning of instruments: 0.2 - 1 % (2 - 10 ml/l) at 40 - 50 °C</p> <p>For machine cleaning of flexible endoscopes: 0,5 % (5 ml/l)</p> <p>Cleaning manually: immersion bath: 0,5 – 2 %, 20 - 30 min ultrasonic bath: 0,5 – 2 %, 5 - 10 min Cleaner solution may optionally be heated to a maximum of 45 °C.</p> <p>The working solution of neodisher MediZym has to be replaced at least daily. Subsequently the neodisher MediZym-solution has to be rinsed out completely by sufficient rinsing. Do not mix with other products.</p> <p>Only for professional use.</p>
